PRESIDENT'S REPORT

OVERVIEW

The highlight of the year has been the increased interest in and activity of United Nations Youth Association, due to the hard work and enthusiasm of Harriet Glen and Julie Herraman and their executive committee. Their competence has resulted in the organisation of student meetings and conferences being left largely in their hands with support from me as President. This has been one of our aims since International Youth Year; to train and encourage young people to run their busy programs of social, fundraising and awareness raising events. Not only have attendances been good, but there is strong competition for the S.A. places to the National Youth Conference in Tasmania.

Our continuing provision of school packs (twice this year) has meant a building up of resources in school libraries. This is an important part of our work, especially with the introduction of the Australian Studies course of SACE. With increasing attention to the UN, we have had many enquiries for information from secondary and tertiary students, as well as teachers, academics and government departments.

Without our band of volunteers we could not provide this service.

Half of our grant from Norman Percy Cole Foundation is used to support our work in schools and with our secondary students especially those at a disadvantage.

This year, the other half of our Norman Percy Cole Trust grant was used to provide Encouragement Grants of up to \$50 to Playgroups, Child-Parent Centres, Child Care groups and primary schools to help them with activities during Childrens Week. It was good to be able to spread the grants across the State, and to see the wide range of events. Many focussed on providing Healthy Breakfasts.

Another important focus during the year has been the sponsorship of the Women Against Demeaning Images Campaign by our Status of Women Committee (together with other women's groups).

REPRESENTATION ON OTHER COMMITTEES AND COOPERATION WITH OTHER ORGANISATIONS

Multicultural Forum and Community Relations Media Forum

My continued attendance has increased the information available to our Association and also provided valuable contacts in this area.

Human Rights Day Committee

This umbrella group planned the main observance which was a lunchtime Forum focussing on the many facets of DEBT. It was well attended and gained media time.

Refugee Week Committee

A wonderful committee to work on, especially due to the Austcare representative in SA, Mrs Lina Caporaso. The 1991 innovation was a maze which helped students to experience the Refugee Journey. I organised a lunch at which Ms Ann Shepherd from UNHCR in Malaysia was keynote speaker. The Week was full of challenging events.

One World Collective

This group is responsible for managing and leasing the floor of Admiral House on which our office is situated. We are still waiting for the Accommodation Task Force to find us all a permanent home. Meantime, security is our main problem

UNICEF

We continue to promote the sale of UNICEF cards and distribute UNICEF information.

Children's Week Committee

The Committee is experiencing difficulties in finding a Chairperson with sufficient time. Meantime, Stewart Barnes is acting chairperson, and I act as Secretary. We are exploring ways of getting more administrative assistance.

1991 Week was very successful. One new event was the running by SADEC of a Simulation game with upper primary students each day. The "TIME FOR PEACE" booklet was launched during the Week.

We have worked closely with Women's International League for Peace and Freedom, Amnesty, Volunteer Centre, South Australian Development Education Centre, Department of Foreign Affairs and Trade, Australian International Assistance Bureau, South Australian Council of Churches, Graham Smith Peace Trust as well as other community groups.

## UNAA STATUS OF WOMEN COMMITTEE REPORT

The past year for the Status of Women Committee has been very interesting with several concerns being raised and a campaign against Women in Demeaning Images.

Over the past year we have had a number of interesting speakers, in particular Hon Ian Gilfillan MLC to speak on the Prostitution Bill and Alice Dixon who spoke on the hardships for Aboriginal families and Deaths in Custody. It was with great sadness and loss that we heard recently of Alice's death. She will be deeply missed by everyone who had come to know her and admire her strength in such adversity.

A number of issues discussed not only included the Prostitution Bill, but the Newstart programme, declining living standards and their effects particularly on women and children. Childcare again was an issue over the new fee relief structure, accreditation and the threatened closure of the Multicultural Childcare Unit. We were able to have effective input into these issues.

Alleyne Womersley gave an interesting account of her visit to the US and UN. David Hawke from the Equal Opportunities Unit outlined his work and the Unit's and the need to reach out to empower particularly NESB women.

However the campaign against Women in Demeaning Images really mobilized women across the board to action. SWC along with YWCA, IWDC and WEL formed a campaign committee to alert all women to this situation, as a result of the People magazine cover and urged a boycott of all material produced by Consolidated Press. The SWC wrote letters of complaint to the media and Consolidated Press. As a result People has now been reclassified and not for general consumption.

All in all we have had a very lively year and planning is already underway looking forward to the 1995 World Congress of Women where advances women have made since the Nairobi Conference at the end of the Decade for Women will be further assessed and again in the year 2000.
